## Being a By-Law to appoint Committee Members and Representatives for the Township of McGarry for the year 2025

Whereas By-Law #2021-57, "Procedural By-Law" provide rules for governing the order and procedures which Council and Committees of Council are to operate and follow; and,

Whereas Council has established committees that are comprised of both members of the public and members of Council; and,

Whereas Council recognizes that throughout the one year term of the Committee new appointments may be required and resignations may be submitted;

**Now Therefore** the Council of the Corporation of the Township of McGarry enacts as follows:

- a) The list of initial appointments for committee members and representatives for the year 2025 are identified in the attached schedule that is marked Schedule "A" and forms part of this By-Law.
- b) All additional appointment and resignations be approved through the adoption of a resolution;
- c) That this By-Law shall take effect on January 1, 2025 and that By-Law 2024-02 be repealed.
